- A data sheet feature is now turned on in SpEd forms and will auto print after each IEP PWN autofilled. They can be manually printed too. (Demo)
- This is replacing the old process of completing a Coop Data -Change Form! No more typing in the info again!
- Notify your due process secretary that you've done a new IEP or made an IEP change so they can print it and get it to the right staff.
- CHANGES to an IEP that you should use this process for include a new annual IEP, amendment, exit from SpEd, etc. Use anytime a data element changes.
- Please work together to follow this process. Data is very important for funding.
